

Dear Customer,

As you well know, starting from 25 May 2018 the new European Regulation on the processing of personal data of individuals (GDPR or General Data Protection Regulation) must be applied in all the member states of the European Union.

As we consider it fundamental to respect the privacy of our customers, we wish to convey to you the following information on Data Processing that concerns you.

## Relative information

FRATELLI CHINI SRL, in its capacity as controller of personal data pursuant to articles 13 and 14 of EU Regulation 679/2016 - General Data Protection Regulation ("RGPD"), in compliance with the obligations dictated by the legislator for the protection of privacy, hereby wish to inform you in advance of both the use of your personal data and your rights, communicating the following:

### a) HOLDER AND OTHER RESPONSABLE PARTIES

The data controller is FRATELLI CHINI SRL, C.F. 00090460510, with registered office in Via Nazionale 246 - SS 69 KM 50 - 52019 - Laterina Pergine Valdarno (AR) - Italy. The updated list of data processors, with the relevant areas of competence, is:

- The list of generic subjects in charge of processing your data is available in the Company and, at your request, will be made available to you.

### b) THE PERSONAL DATA PROCESSED

- Non-specific personal data (identification, accounting, financial, etc.) - Personal and accounting data relating to Customers - Duration of treatment: 10 Years.
- Other particular data - Video surveillance of accesses - Duration of treatment: 10 days

### c) PURPOSE, LEGAL BASIS AND OBLIGATORY OR OPTIONAL NATURE OF TREATMENT

#### Main Purpose

- Data Processing the sole purpose of Customer Management:
- Pictures and video recordings of accesses for surveillance and security of the premises (filming is not carried out within work premises but only at the entrances)

Legal basis: the interested party has expressed his/her consent to the processing of his/her personal data for one or more specific purposes or issues of legal bases.

### d) RECIPIENTS

Exclusively for the purposes indicated above, the data will be made known, in addition to the competent internal staff units, also to external collaborators responsible for their processing, the list of which is available at the company headquarters.

e) *TRANSFERS*

*There is no transfer of Personal Data information to recipients outside the European Union*

f) *DATA RETENTION*

*All personal data provided will be treated in accordance with the principles of lawfulness, correctness, relevance and proportionality, only with the methods, including computerized and online, strictly necessary to pursue the purposes described above. In any case, personal data will be stored for a period of time not exceeding that strictly necessary to achieve the indicated purposes. Personal data for which conservation is not necessary or for which storage is not required by current legislation, in relation to the stated purposes, will be deleted or transformed into an anonymous form. It should be noted that the information systems used for the management of the collected information are configured, from the outset, in order to minimize data usage.*

g) *YOUR RIGHTS*
